



## Installation Instructions Top Slider 87-06 Jeep Wrangler

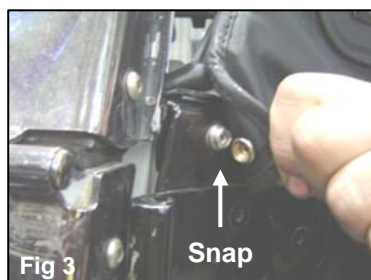
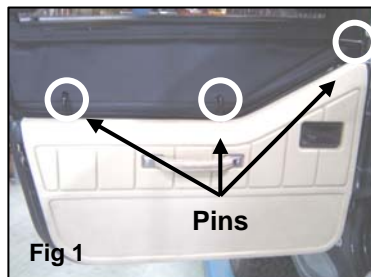

### **INSTALLATION INSTRUCTIONS**

1. Starting with the front Pin, slip the pins on the bottom of the Top Slider into factory door inserts in the lower door (Figure 1). Make sure that the pins are well seated in the factory door inserts. Close the door to check that it fits properly against the body. **NOTE:** If Top Slider does not fit properly, you may tilt Top Slider front to back until it seats properly.  
**87-95 Wranglers:** Insert Plastic Strip on the bottom of the Top Slider into factory channel on the lower door (Figure 2). Locate Snap on the Top Slider and attach it to factory snap on the lower door (Figure 3).
2. Locate (1) Latch Hook and attach it to already installed Latch Handle. To install the Latch Hook, slide one pin at a time into Latch Handle (Figure 4), once both pins are in the Latch Handle, push it all the way until it is fully engaged. **NOTE:** Be careful not to break pins on the Latch Hook when engaging.
3. Repeat Step 1 & 2 for opposite side.
4. To open the window, squeeze the release button and slide the window open (Figure 4).
